# Introduction

The Arts Foundation was set up by anonymous bequest in order to support UK-based artists from across the spectrum of the Arts. Since 1993 we have given nearly £2million to creatives. The annual Arts Foundation Futures Awards (AFFAs) gives out five £10,000 fellowships every year. These are awarded on the basis of past work and enable future development.

The contribution of the Arts Foundation awards to the arts in the UK is demonstrated by many of our fellows. To name just a few: Wayne McGregor (Choreographer, 1994); Sarah Kane (Playwriting, 1998); Ali Smith (Writer, 2001); Asif Kapadia (Film Directing, 2001); Rufus Norris (Theatre, 2002); Carol Morley (Film, 2003); Brothers Quay (Animation, 2004). For some, the award has given them the support and encouragement to pursue their practice full-time such as Lynette Yiadom-Boakye.

Changing categories allows us to keep highlighting innovative practices in both new and traditional art forms and shining a spotlight on practices that might be less well served by other awards at the time.

To identify the most talented and deserving artists resident in the UK, the Arts Foundation select professionals close to the art forms to feed into the process of nomination and judging. The winner gets  $\pm 10,000$ , the other three shortlisted each receive  $\pm 1,000$ .

AF is seeking an energetic Interim Director on a six-month contract to deliver the 2022 Arts

Foundation Futures Awards in January and manage the foundation while it reviews it's future strategy. There is a possibility of extending this role beyond the initial six months. The Arts Foundation has no office, so the postholder will be expected to work from home, unless by agreement

# **Duties**

# **Arts Foundation Future Awards**

Management of the Arts Foundation Futures Award (AFFA) scheme following announcement of the 20 finalists, including producing the AFFAs 2021, an online awards ceremony taking place in January 2022. Liaising with nominators, judges, trustees, applicants and sponsors through the process. Role includes devising and managing the online content for the live event, invites to the event stakeholder management, fundraising, advocacy and promotion

Working with the board to identify 2023 awards, setting up nominators network for each artform and seeking outstanding nominators/judges in all disciplines through research and face to face meetings with leading artists, curators, educationalists, promoters.

Preparing and issuing agenda notes and other papers for Trustees' meetings, including information about future awards

Preparing and circulating draft Minutes of Trustees meetings

Drafting the Trustees' Annual Report for consideration by the Trustees

Advising Trustees, as appropriate, of any obligations relating to the Trust Deed, the requirements of the Charity Commission and HMRC, or other matters relating to the conduct of the charity
